

Terms of Use



This agreement is made between you as a user and platform LUMINUS.

Using the services of the site LUMINUS, you agree that you have read and accepted all the conditions described in this agreement, as well as become familiar with our privacy policy.

If you do not agree with this agreement, immediately stop using the services of the platform LUMINUS.

By creating your account at LUMINUS, you consent to the terms and conditions set forth in this User Agreement.

You agree not to assign any rights or obligations under these terms, whether by operation of law or otherwise, without our prior written consent. We may assign our rights and obligations under these Terms in our sole discretion to an affiliate or in connection with a subcontractor, offshore company, acquisition, sale, or merger.

If any paragraphs or clauses contained in this Terms of Use become unenforceable or invalid, this would not affect the applicability of any of the other parts of this Terms of Use and/or the validity of this entire policy.

Terms and Definitions

1. Agreement is a list of the conditions that users must accept to continue working on the platform LUMINUS.
2. Cryptocurrency : a peer-to-peer electronic currency that does not have a single centralized issuer and is distributed between holders of such a currency.
3. Cloud mining: Cloud mining is the process of cryptocurrency mining utilizing a remote data center with shared processing power.
4. A personal account is a page inside the platform that is created as a result of registration and acceptance of the User Agreement.
5. Privacy policy: these are the rules for the collection, storage, and use of personal data by users.
6. User is a natural or legal person registered in accordance with local national legislation who has registered and accepted the User Agreement.
7. Deposit and withdrawal of funds: an operation to transfer the user's funds from a personal account
8. Account data: personal data of the user; this is the username, password, and email address that the user specified when registering on the platform LUMINUS.

Terms of agreement

About such changes LUMINUS will notify all users by the specified mail by the user, and all updates will be displayed in the Agreement Terms themselves.

If you continue to work on the platform, then you automatically accept these updates.

By creating an account in LUMINUS, you confirm that you are at least 18 years old and you are an individual or legal entity, an organization that is fully authorized to accept this User Agreement between you and LUMINUS.

Prohibition of use

Using the services of the platform LUMINUS, you declare that you are not on any list of trade or economic sanctions, such as the List of Sanctions of the UN Security Council and the like.

While using LUMINUS, you agree not to:

- a. Engage in illegal activities, including money laundering, fraud, or any other criminal behavior.
- b. Disrupt the platform's functionality, attempt to hack, or gain unauthorized access to our systems.
- c. Transmit or share any content that is offensive, harmful, engages in bullying, or violates the rights of others.
- d. Transfers cannot surpass predefined limits set by active plans under any circumstances. Any attempt to exceed these limits is strictly prohibited.

This agreement cannot be excluded under the laws of the country in which the user is located.

Project Description and Company Identity

LUMINUS is a cloud mining cryptocurrency project that gives users the opportunity to earn from bitcoin mining without installing any hardware.

Users have the opportunity to register, open accounts, and deposit assets in LUMINUS. Platform users have the right to request the withdrawal of their funds, taking into account the restrictions specified in the terms of the agreement, if any.

User data authentication

By creating an account with LUMINUS, you agree to provide personal data to verify the authenticity of your identity.

These measures are necessary to detect and prevent schemes of money laundering, fraud, financing of terrorist organizations and other financial crimes.

After registration, you must ensure that your information provided is complete, truthful, and you will be updated in a timely manner in the event of a change.

If there is any doubt that the information you submitted is untrue or is outdated or incomplete, LUMINUS has the right to send you a notification asking you to correct or update personal data.

You take full responsibility for any losses or expenses incurred at the time of use LUMINUS if you cannot contact in a timely manner and update your personal information.

By this agreement, you acknowledge that you undertake to update personal information in case of any changes.

Risk of service

a. Investment Risk: Investing in cryptocurrencies, including Bitcoin mining, carries inherent risks. Prices can be highly volatile, and you may lose all or part of your investment. Ultimately, you are solely responsible for your investment decisions.

b. Security: You are responsible for maintaining the security of your wallet and private keys. LUMINUS is not liable for any losses or damages resulting from your failure to secure your assets properly.

c. Regulatory Compliance: Cryptocurrency regulations vary by jurisdiction. It is your responsibility to comply with the laws and regulations in your area regarding cryptocurrency use.

d. Mining Rig: Each user is issued a mining machine upon successful registration and activation of the mining contract. LUMINUS offers cloud mining hosting services only, and maintenance and upgrades of mining machines are in the hands of the mining rig owner.

LUMINUS reserves the right, at its sole discretion, to upgrade, modify, or decommission any part of the mining infrastructure not meeting the required power output of the mining pool under their usage without any obligation to notify users or seek their approval.

You agree that we are not responsible for any activity developed by any third-party websites, affiliates or companies and that you should inform yourself about their own terms of use and privacy policies before accessing their services.

Termination

You agree that LUMINUS has the right to stop your use of the platform and block funds if it is suspected that such accounts have violated the terms of the agreement, the privacy policy, or other applicable legislation. LUMINUS has the right to save, use, and provide transaction data for violators at the request of the legislature.

The termination of the agreement is possible due to such factors as:

by order of a court or other regulatory authority. if unauthorized access to the account is detected. if non-natural account activity is detected. After the account is closed and the funds are blocked, the entire balance of the user will go to pay off all costs and expenses.

Privacy policy

The privacy policy is an important clause of this agreement. LUMINUS may, if necessary, amend this clause of the agreement. All changes to the privacy policy and any other clauses will be notified to all users through the mailing list indicated by their email.
